

Minutes from Althing : October 2, 2004  
Held at Gryphon's Perch

King Gregor opened the Althing. He had no report at this time.

Princess Kizmit reported on feast costs from Coronation V. \$600 had been approved. \$570 was spent. She also reported on an Ithra that is being planned for the end of this reign.

**Item 1** on the Agenda was read. "Remove relics are not lootable at all." Discussions were held. A vote was taken. 7 for, 1 against, 1 abstain. With the absentee votes the final vote was:

48 for  
29 against  
5 abstain.  
Item passed.

**Item 2** "Champion should not have to pay event fees or dues" was withdrawn for proper wording.

**Item 3** "Remove absentee voting from our current form of voting for an Althing." Discussions were held and a vote was taken. 2 for, 8 against, 0 abstain. With the absentee votes the final vote was:

4 for  
77 against  
2 abstain.  
Item failed.

**Item 4** "Althings are to be held at or around Gryphon's Perch in Indianapolis, Indiana permanently." Discussions were held and a vote was taken. 2 for, 7 against, 0 abstain. With the absentee votes the final vote was:

13 for  
53 against  
0 abstains.  
Item failed.

**Item 5** "Monarchy is responsible for setting the date of the next Althing at the current Althing. Sir Owl made a motion this item be tabled for rewording. Griever seconded the motion. A vote was taken on tabling this item. 8 for, 0 against, 0 abstain. Sir Owl stated he will be responsible for rewording this item and presenting it at the next Althing.

King Gregor opened the floor for new business. The following items were presented to be on the Agenda at the next Althing, if the King chooses.

Sir Owl made a motion that all instances of Valkyrie be removed from the Corpora. Tugen seconded the motion.

Owl made a motion to add sections VI.4.b.iv and VI.4.b.v to the Corpora. Section VI.4.b.iv. to read "The Corpora takes precedence over any Althing decision." Section VI.4.b.v to read "Any change to the Corpora must be written in the proper form of the Corpora." Tugen seconded the motion.

Azmandius made a motion to revert section 1 of the Monetary Document to "Kingdom level Dues Paid Members (DPM) will receive 10 Talons upon becoming dues paid." Tugen seconded the motion.

Tugen made a motion to add Section IV.1.c.ii to read "Is not required to pay any dues or fees during his/her term." This is in reference to the office of Champion of the Realm. Cassia seconded the motion.

King Gregor made a motion to add Section II.3.a.v to read "At the end of his or her term, the Monarch shall present a list of awards, titles, and honors given by him/her during his/her reign to the incoming Monarch or the Prime Minister." The motion continued to add Section II.4.a.vii to read "At the end of his or her term, the Regent shall present a list of awards, titles, and honors given by him/her during his/her reign to the incoming Monarch or Prime Minister." Griever seconded the motion.

Tugen made the motion to remove the rules clarification that "Hits to a hand wielding a polearm count as a hit to the polearm." Cassia seconded the motion.

Tugen made a motion to revise Section VI.4.a.v to read "Rules clarifications may not contradict explicit wording of the official rules. A rule may be changed by an Althing decision or IRCA ruling in instances where safety is concerned." Griever seconded the motion.

King Gregor mentioned there were three items from the previous Althing that had not been carried over. He will add those items to the agenda for the next Althing.

King Gregor made a motion to adjourn the meeting as no one had any further new business. Azmandius seconded the motion. Motion passed. The Althing was adjourned.
